Candy/Dessert Buffet Agreement

We look forward to creating part of the fun and excitement at your upcoming special event. The following terms and conditions pertain to your service with Sweet Couture Candy Buffet.

1. Our Commitment

Every Candy Buffet includes the following services:

1. Consultation with a Sweet Couture design expert so that we may create your Candy Buffet to achieve the look you like.
2. Submit to you a list of candy, which you can choose from and/or upgrade for your buffet.
3. Set-up the buffet at the desired location at your event.
4. Disassemble the buffet and its cleanup.
5. Packaging of all leftover candy for you to take home.

2. Provision for Physical Facilities

In order to ensure a successful event, it is necessary that Candy Buffet and/or Dessert Table be set up properly. We therefore require access to the desired setup area at least 1-2 hours prior to the beginning of the event. We also require 1 hour after the conclusion of the event to disassemble and clean up and take down the buffet.

3. Payment Terms

You agree to pay in full the balance of the buffet service and rental fees, and any other additional option cost agreed upon. The balance must be paid 14 days prior to the date of your scheduled event. If the balance is not paid by this date we cannot guarantee your event time and the contract will become null and void and you will forfeit your deposit.



4. Retainer Fee

In order to secure the availability of the **DIY Package** for your event, we require a refundable retainer fee of:

- Three Hundred dollars (\$300) for our DIY Package #1
- Five Hundred dollars (\$500) for our DIY Package #2
- The execution of the agreement contract

In order to secure the availability of the Candy Buffet and/or Dessert Table Packages, we require a non-refundable retainer fee of:

- 50% down for all of our Candy Buffet Packages and Dessert Tables
- The execution of the agreement contract

*The client understand and agree that the retainer fee for all DIY Packages is contingent upon all rental items returned in the same condition without lost, damage or stolen.

5. Client Responsibility

You agree to provide at the desired setup area the following:

1. One 6-8' sturdy table that is needed for the Candy Buffet/Dessert Table provided that one is not being rented from Sweet Couture Candy Buffet.
2. Sufficient power for the operation of the up-lighting (if applicable), which requires at least one 120-volt circuit that supplies at least 15 amps, according to normal safety standards, within 15 feet of the set up area.

6. Liability

Client agrees to assume full responsibility for any and all claims arising out of the use of the candy buffet/dessert table or its attendants. Sweet Couture Candy Buffet will not be liable for any injury, allergic reaction, loss or damage directly or consequently arising out of the use rental of the candy buffet/dessert table. Client indemnify Sweet Couture Candy Buffet harmless from all claims, actions, proceedings, costs, damages and liability including attorney fees and court cost arising out in connections with or resulting from the services of Sweet Couture Candy Buffet.
